

GSWPGA GENERAL MEETING AND AWARDS LUNCHEON
NOVEMBER 12, 2009

President Myrt Rogneby called the meeting to order following lunch. The secretary called the roll with response as follows:

Auburn 1; Bellevue 8; Cascade 2; Foster 4; Jackson Jills 15; Jefferson Park 3; Lake Wilderness 8; Maplewood 14; Mt. Si 0; River Bend 6; Snoqualmie Falls 0; Twin Rivers 3; Wayne 4; and West Seattle 1.

Dawn Rumpf moved that the minutes be accepted as presented via email. Approved.

Treasurer Audrey Campbell reported that we had 32 more participants in tournaments this past season, resulting in more green fee and entry fee income and more money going into the General Fund. We brought in \$440 for our President's Cup raffle. Our association expenses overran the budget by \$298.42, which was mainly due to a \$150 overrun for the City Championship trophies and also an \$88 overrun to the website.

Kren also went over the language clarification for team eligibility. City Reps will be getting this printed out at the spring meeting.
