Historian/Website

Mary Ryan says that if we have google calendars we can link to the calendar at gswpga.com so that our tournament and team events will download onto our personal calendars. Mary will be sharing “how to” information on this process.

Old Business

In September the Executive Committee distributed a proposed Constitution/By-Laws revision to all member clubs. The proposal adds club responsibility for providing a Tournament Director per a schedule to be published in the Standing Rules.

Attendees requested a discussion of the proposal prior to a roll call vote. Some felt that the proposal would put undue burden on smaller clubs. It was noted that the TD role had been filled for thirteen of the last seventeen years by members of Cascade which is a small club. It was pointed out that a club can get a volunteer from any member club. Carrie said that repeatedly going 7-9 months waiting for someone to volunteer for this critical position was stressful for the Executive Committee knowing the position would be vacant the next year. This is the second time in three years that this situation has occurred. It was suggested that getting this change into our documentation will encourage the member clubs to address the issue in a more planned and deliberate manner. It was also noted that GSWPGA cannot exist without a Tournament Director.

Cindy Andre conducted the Roll Call vote. Results: Yes - 25, No – 12.

The Constitution/By-Laws will be updated as will the supporting sections of the Standing Rules. The documentation will be distributed via email and be available on the web page (gswpga.com) once the update/review process is complete. This change will be reviewed each year as we go forward.

New Business

Standing Rules Revisions – Carrie reported that the requirement for declaring a home club at the beginning of the year has been replaced with the requirement to declare a home Team prior to team play along with information about how that process will work.

President’s Charity Cup

Janet reported that \$519 will be donated to Meals on Wheels Carrie’s chosen charity.

Luncheon Raffle

The luncheon raffle raised \$577 which will be split between the Evan’s Golf Scholarship and Washington State Junior Golf.
